STATUS:

Phase 1 - Noonan Reservoir – This project is being analyzed for alternative strategies for water storage and/or land uses for the Noonan site due to the \$50 Million plus estimated project cost for the above ground storage reservoir which includes foundation treatment to mitigate soil liquefaction potential from a seismic event. Project participants include Benicia, Fairfield, Maine Prairie, SID, SSWA, Vacaville, and Vallejo.

Phase 2A – NBA-Highline Canal-Inter Tie Project - This project has been on hold pending adoption by DWR of the alternative alignment for the new NBA intake. Project participants include Benicia, Fairfield, and Vacaville.

Activities completed in 2016:

- Identified alternative water storage strategy option for an in-ground water storage reservoir.
- Prepared schematic drawings of reservoir.
- Calculated excavation volume and water storage capacity options.
- Develop planning level estimate of costs

Activities completed in 2017:

- Identified alternative land use options for water related projects
 - ❖ Ground water recharge basin
 - ❖ Wetlands for treatment of recycled water
 - ❖ Habitat conservation area.

Activities planned for 2018:

- Analyze alternative land use options identified in 2017.

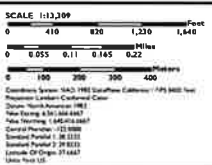

Progress Report

The New Water Supply Project Task Force has been inactive since the last status report in October 2016. This is the result of the successful completion of the Phase 2A settlement, the economic downturn and subsequent State-wide drought which reduced water demands in all of the SWA3 participating cities, and the late 2013 settlement of the Area of Origin litigation related to our State Water Project (SWP) contract supplies.

The last two wet winters have restored SWP deliveries and have filled Lake Berryessa. While water use is again on the rise in several Solano County cities, many conservation practices have become permanent and consumption levels still remain below 2013 water usage levels. Therefore, it is not anticipated that the SWA Project No. 3 participants will actively pursue additional water supplies in the upcoming year – there are adequate water resources anticipated to be available within the County in 2018. Therefore, water resources planning activities will be coordinated more generally through the Solano Water Advisory Commission. The information below is largely unchanged from last year's update and the two years before that.

Phase 1

There has been no recent activity on this item. The participating agencies have been cooperatively managing the supplies we currently have due to the reasons stated above. The two primary activities carried out over the past 10 years are described below.

As an outgrowth of the 2005 "Solano Agencies Integrated Regional Water Management Plan," Solano Irrigation District (SID) proposed negotiations for a permanent sale of up to 5,000 acre-feet per year of Solano Project (Lake Berryessa) water supply from SID to

interested Solano cities. Fairfield, Benicia, and Vallejo staff expressed interest and began meeting with SID staff in June 2005, assisted by Solano County Water Agency. Vallejo subsequently decided not to proceed.

Negotiations and CEQA compliance were completed successfully, and in April and May 2009, Fairfield and Benicia entered water purchase agreements with SID for 2,000 acre-feet per year each, starting in 2009. The significant financial terms were \$2,500 per acre-foot water supply contracted (lump sum up front) plus \$62.62 (2008 dollars) per acre foot paid annually, adjusted annually for inflation.

In 2007, SCWA filed a claim with the state regarding area of origin preference for water supply from the State Water Project, which, as expected, was denied, clearing the way for a lawsuit, which SCWA and other parties filed in 2008. A settlement was reached and was finalized in late 2013. This litigation and settlement effort was carried out by SCWA outside of SWA3. The most significant positive outcome from this legal effort was a separate "North of Delta" SWP allocation, which provides greater SWP reliability for Solano County agencies.

Phase 2A

The Phase 2A "watershed of origin" water rights settlement agreement between the Department of Water Resources, SCWA, and the three cities of Fairfield, Vacaville, and Benicia reached a successful conclusion in the latter half of 2003, bringing nearly 32,000 AF/yr of new urban water supply to Solano County.

At a meeting in April 2008, the Policy Committee approved a \$50,000 increase in the project expenditure limit and budget, primarily for ongoing legal services needed to assist the cities in administering, maintaining, and defending the settlement. These funds have been deposited and the legal services agreement with Somach, Simmons & Dunn was extended at that time.

The reason funding was set aside was to address potential legal challenges or other complications to this settlement. However, no such legal issues have arisen and there has been no recent activity on this item.

TITLE: SWA Agreement #4, Coordinated Groundwater Management

SUBJECT: Update on Recent and Planned Activities
Presented for Informational Purposes, No Committee Action Required

EXECUTIVE SUMMARY:

Since 1993 this agreement has facilitated the collection, sharing and reporting of groundwater data for Putah Fan/Tehama Formation groundwater basin. No new activities are planned for 2017-18 but groundwater monitoring and data collection activities will continue.

BACKGROUND:

The SWA Agreement #4 (SWA4) was entered into on August 12, 1993 among six agencies. In order to prevent overdrafting and contaminating the Putah Fan/Tehama Formation groundwater basin, data about water quantity and quality in the basin is collected and shared among the agencies. Effects of existing and planned pumping from the basin are the main interest. The Lead Agency is SID; SCWA and Vacaville are actively participating, and SCWA provides staff support.

Past activities have included:

- SCWA collection of groundwater data and the publication of several groundwater reports.
- SCWA compilation of a groundwater database
- Publication of the North Central Solano County Groundwater Resources Report by Summers Engineering, Inc., in 1995.
- The Solano Groundwater Investigation Project including:
 - Construction of four deep groundwater monitoring wells by SCWA
 - Construction of a conjunctive use test well on a site owned by RD 2068. This was partially funded by AB 303 grant funds acquired by SCWA.
 - Preparation of Technical Memorandums documenting the work accomplished.
 - Implementation of groundwater monitoring data required by SBx7-6
- SID preparation of annual Groundwater Status Reports.

Note that no new activities were planned for FY 2016-17. The following ongoing activities took place:

- Continued groundwater monitoring and data collection for California Statewide Groundwater Elevation Monitoring (CASGEM) reporting to the state DWR.
- SWA 4 agencies formed Groundwater Management Agencies in Solano County, but SWA4 itself did not participate in this.

Planned/potential activities for 2017-18 include:

- Continued CASGEM data collection and reporting.
- SID will have Summers Engineering prepare an updated Groundwater Status Report – Water Levels and Quality upon taking the fall 2017 groundwater level readings. This report will be presented to the District’s Board of Directors in December.
- Participate in development of Groundwater Sustainability Plans (GSPs) in conformance with adopted state groundwater regulations.


